

ORDINANCE 07-09

**AN ORDINANCE TO AMEND THE BUILDING CODE OF SKY VALLEY  
ORDINANCE (05-01) IN ORDER TO ELIMINATE PROVISIONS OF THE BUILDING  
CODE NOT REQUIRED BY STATE STATUTES AND REGULATIONS**

WHEREAS, the City of Sky Valley recognizes the need to establish building code requirements consistent with standards commonly used in the industry, and

THEREFORE, the Council of the City of Sky Valley hereby ordains:

I. The Building Code of the City of Sky Valley is hereby amended as follows:

Section 300.50(1) is amended by deleting the current Section 300.50(1) in its entirety and substituting a new section to read as follows:


(1) **Copper Conductors** – No copper clad or aluminum wire will be permitted as an electrical conductor from the meter base on any commercial or multi-family buildings. Only true copper conductors of electrical energy will be approved on those structures. Copper conductors from the meter base are acceptable on single family homes, but not required by the City. All electrical conductors must meet or exceed the National Electric Code.

II. SHOULD ANY SECTION OR PROVISION OF THIS ORDINANCE AMENDMENT BE DECLARED BY A COURT OF COMPETENT JURISDICTION TO BE UNCONSTITUTIONAL OR INVALID SUCH DECLARATION SHALL NOT AFFECT THE VALIDITY OF THE ORDINANCE AS A WHOLE OR ANY PART THEREOF OTHER THAN THE PART SO DECLARED TO BE UNCONSTITUTIONAL OR INVALID. ALL RESOLUTIONS AND ORDINANCES AND PARTS OF RESOLUTIONS AND ORDINANCES IN CONFLICT WITH THE PROVISIONS OF THIS ORDINANCE ARE HEREBY REPEALED.

III. THIS ORDINANCE AMENDMENT WILL BECOME EFFECTIVE UPON ADOPTION BY THE CITY COUNCIL AND APPROVED BY THE MAYOR AS PROVIDED BY THE CHARTER OF THE CITY OF SKY VALLEY.






